



**UITM INTERNATIONAL SPORTS FIESTA
RULES AND REGULATIONS
TENNIS**

1.0 Rules

The competition will be held in accordance with the rule of International Tennis Federation (ITF).

2.0 Eligibility

This tournament is by INVITATION ONLY.

- 2.1 STUDENTS of UNIVERSITIES
- 2.2 Each team must consist maximum 10 players with minimum 4 male and 4 female. Each university is eligible for 3 teams only.
- 2.3 Each university may register a maximum of two (2) teams.

3.0 Event

3.1 This tournament will consist of **TEAM EVENT**.

3.2 The **TEAM EVENT** ties will consist of 5 categories which are:

- a. Men's Single
- b. Women's Single
- c. Men's Double
- d. Women's Double
- e. Mixed Double

3.3 **Each player** is only **allowed to play ONE event in every tie**. Repetitive playing in other categories in the same tie is not allowed.

- 3.4 "Pro Set" systems will be used in UiSF. "Pro Set" is the first to reach 8 games by margin of two games, instead of first to 6 games. A 7 point tie-break is usually played when the score is 8-8. If the score is 7-7 the games will played until 9-7.

4.0 Walkover/Disqualification

Team event:

No walkover is allowed in any matches in round robin .The team will be considered as null if walkover has been done.

5.0 Format

The team event will be playing by the "Pro Set" system in accordance to ITF rules and regulations.

6.0 Appointment of referee to Matches

The Technical Committee with the assistance of the Official Referee or his authorized representative shall be responsible for the appointment of the registered ITF referee.

7.0 Equipment / Ball

8.0 Protest

8.1 A protest should be reported immediately so that it may be heard in a timely manner (30 minutes after the match end). Any protest of player eligibility must be made prior to a game. Failure to protest eligibility prior to a game will waive a team's opportunity to protest any player's eligibility for that game.

8.2 All protests must be in writing and accompanied by the official protest fee of RM 500.00 (Ringgit Malaysia: FIVE HUNDRED ONLY) cash as a deposit. This fee is refundable only if the matter is ruled in the favour of the protesting party.

9.0 Prizes

The prizes of the UiTM International Sports Fiesta will be provided by the Organizing Committee. Certificates of participation will be presented to all participants and officials of the Games.

10.0 Others Matter

In all others matter not covered by the preceding rules, the decision of the Organizing Committee shall be final.
